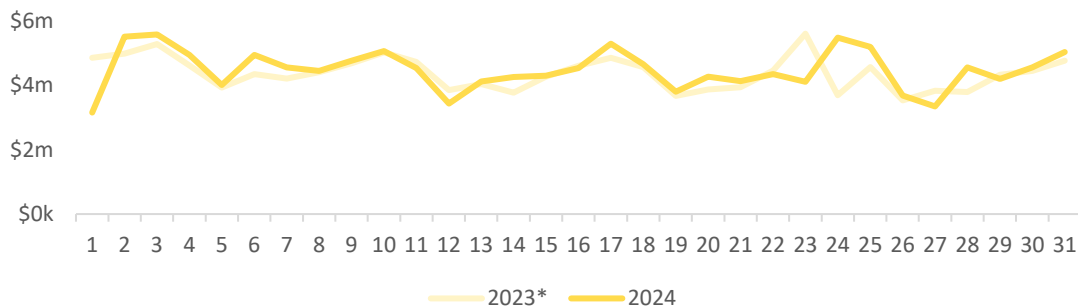

Total spend
